2. I must submit a printed copy of my required Entry Description Summary at registration on Saturday or Sunday, November 15-16, 2025.
3. I must deliver my completed entry to OGPI on Saturday or Sunday, November 15-16, 2025, at the time assigned to my division.
4. I acknowledge that if selected as a Top 3 finalist from my category, I must make best effort to be available following the Awards Ceremony on Monday, November 17, 2025, and on Tuesday, November 18, 2025, for additional video content needs.
5. I acknowledge that my entry will remain on display during the OGPI holiday season through January 4, 2026. My entry may not be picked up prior to January 5, 2026.
6. I acknowledge that if selected as the Grand Prize Winner, 2nd Place Adult, or 3rd Place Adult, my entry may be displayed at the OGPI for twelve (12) months following the Awards Ceremony. During these twelve (12) months, while my entry is on display at the OGPI, I agree to maintain my entry for a period of twelve. Maintenance includes ensuring that my entry remains intact and presentable. Any necessary repairs or upkeep required to preserve my entry's original condition is my responsibility and will be addressed in a timely manner.
7. I must pick up my entry between the hours of 10am and 6pm on Monday, January 5 or Tuesday, January 6, 2026. Entries remaining will be discarded beginning at 7pm on Tuesday, January 6, 2026.
